SECTION:	Public Hearing	Board Meeting:	December 15	, 2021

<u>ISSUE:</u> Conduct Public Hearing to Consider Public Input regarding the trustee area map plan scenarios prepared by the District demographer and vetted by the public at a community forum held on November 10, 2021.

<u>ANALYSIS</u>: At the Board meeting of October 23, 2019, the Board adopted Resolution No. 2019-20 directing the Superintendent or his designee, among other things, to initiate the process of changing the method of electing members of the Board, from the current at-large system whereby each member of the Board is elected by the registered voters of the entire District (Education Code section 5030(a)), to a method which provides that Board members residing in each trustee area will be elected by the registered voters of that particular trustee area (Education Code 5030(b)), in sufficient time for the new method of electing members of the Board to be in place for the November 2022 election.

Elections Code section 10010(a)(1) requires the District to hold at least two public hearings to invite community input regarding the composition of the trustee areas over a period not to exceed 30 days. "Composition of the trustee areas" includes factors such as visible natural and man-made geographical and topographical features, communities of interest, jurisdictional boundaries and population growth. The District held these hearings on May 26, 2021 and June 16, 2021.

Elections Code section 10010(a)(1) encourages political subdivisions to conduct outreach to the public, including to non-English-speaking communities, to explain the districting process and to encourage public participation. The District accomplished this at a recent community forum held on November 10, 2021.

To further encourage public participation, the District has reached out to the public via social media and added a link to its webpage regarding the transition process. Updates and resources regarding the transition process as well as draft maps are posted on the District website.

By law, the District must conduct a minimum of two (2) public hearings on the trustee area map plan scenarios prepared by its demographer before the board may select a final plan. The first such hearing was held at the District Board Meeting held on November 17, 2021. Tonight is the second such public hearing.

The board will invite public comment and input on the draft map scenarios, including two new map scenarios that have been prepared by the District demographer based upon input from the board and the community. Following the public hearing, the board may choose to adopt a trustee area map, or alternatively, opt to conduct a subsequent public hearing at a subsequent board meeting to provide further input before making a final map selection with its accompanying sequencing of the trustee area elections that will begin with the conduct of the 2020 governing board election in November of 2022.

TRUSTEE AREA MAPS

NOTICE IS HEREBY GIVEN that the Governing Board of the Liberty Union High School District at its regularly scheduled meeting on December 15, 2021 at 7:00 p.m. will invite public input regarding the draft trustee area map plan scenarios attached to this notice.

The public hearing will be held at the:

This public hearing is part of the statutory process for establishing a "by-trustee area" elections system. In a by-trustee area elections system, the Liberty Union High School District would be divided into trustee areas and each Governing Board member would be elected by only the registered voters in the particular trustee area where the Governing Board member resides. The Governing Board is currently elected using an at-large elections system, in which all Governing Board members are elected by voters of the entire District. At two previous public hearings, the District's demographer received input into the creation of draft trustee area map plan scenarios which were subsequently shared with the public a community input meeting held on November 10, 2021. At a third public hearing held on November 17, 2021, the public was provided an opportunity to comment on draft map scenarios and election sequencing prepared by the District's demographer. By law, the District must conduct at least two public hearings on the draft map plans prior to selecting a final by-trustee area election map plan for the election of Governing Board members commencing in November of 2022.





En un sistema de elecciones por áreas administradoras, el Distrito Liberty Union High School se dividiría en áreas administradoras y cada miembro de la Junta Directiva sería elegido sólo por los votantes registrados en el área administradora particular donde reside el miembro de la Junta Directiva. La Junta Directiva se elige actualmente mediante un sistema de elecciones generales, en el que todos los miembros de la Junta Directiva son elegidos por votantes de todo el Distrito Liberty Union High School. En las dos audiencias públicas anteriores, el demógrafo del distrito recibió información para la creación de escenarios del plan del mapa de las áreas administradoras que posteriormente se compartió con el público en la reunión de opinión de la comunidad que se llevó a cabo el 10 de noviembre de 2021. En una tercera audiencia pública que se celebró el 17 de noviembre de 2021, se brindó al público la oportunidad de comentar sobre los escenarios preliminares del mapa y la secuencia de elecciones preparados por el demógrafo del Distrito. Por ley, el Distrito debe llevar a cabo al menos dos audiencias públicas sobre los planes del mapa antes de seleccionar un plan definitivo del mapa de elecciones de las áreas administradoras, para la elección de los miembros de la Junta Directiva a partir de noviembre de 2022.
