## **Contra Costa County SARB Process**

The county School Attendance Review Board may conduct hearings, as appropriate, for students who are served in county operated programs, such as community schools and county authorized charter schools.

Each school is responsible for identifying students who are excessively absent and notifying the parent/guardian regarding these absences, according to their site based SART/SARB Process. Every effort should be made to determine the root causes of the student's poor attendance. When possible, the school will provide appropriate interventions and referrals as needed. If the student's attendance does not improve after three truancy notifications, a referral may be made to the County SARB.
