8. SUPERINTENDENT'S UPDATE

Superintendent Sakata shared highlights of her recent activities which included: the Capital Advisors presentation at the County Office of Education. She and Deputy Superintendent Comfort attended the California County Superintendents Educational Service Association quarterly meeting. Ms. Sakata also attended the ACSA Region VI Leadership Assembly by proxy and the East Bay Leadership Council Dinner. Ms. Sakata, along with Board members Alleyne, Belle, and Chavez attended the California County Boards of Education (CCBE), new Board member training in Sacramento. 10. CABINET MEMBER UPDATES

Deputy Superintendent Comfort, gave a presentation on the development of the LCAP to county offices from across the state. She attended a California County Superintendents Educational Services Association (CCSESA) Curriculum and Instruction Steering meeting. She also attended the California Technology Education Incentive Grant (CTEIG) meeting facilitated by Director of Programs, Janet Haun. She attended a curriculum event at U C Berkeley on K-8 science curriculum. Associate Superintendent, Bill Clark, reported the charter review committee has completed their first formal review of the Making Waves petition. His department has been working on the new changes to STRS retirement reporting. Assistant Superintendent, Katie Gaines, shared information about the Annual Teacher Recruitment Fair, which will take place March 4 at Alhambra High School in Lafayette. Chief Communications Officer, Terry Koehne, shared that he and Superintendent Sakata will give a presentation at an upcoming Leadership Contra Costa meeting. The Academic Decathlon competition will wrap up shortly and the awards will be held February 8 at COE. The Mock Trial program will begin on February 7 and continue through the month. Chief Technology Officer, Mac Carey, shared infrastructure improvements to seven of the eleven sites scheduled has been completed. Bandwidth for the COE will be increased shortly. He invited the board to enroll in the free cybersecurity program being offered. This will include video training on how to stay safe with email, etc.

Mr. Belle shared CSBA State Legislative Day is March 21. He highlighted the following legislation: AB 45 – California School Employee Housing Assistance grant; AB 47 – Budget Act; AB 81 – English Learner Identification Bill; AB 163 and AB 173 – reduction of peace officers on school campuses; and AB 169 – teacher credentialing incentive bill.

Dr. Alleyne shared the legislation that was discussed at the recent CCBE Workshop; SB 707 – firearms on campus; AB 1748 – Opioid overdose; AB 1386 Epinephrine injectors; and AB 2246 Pupil Suicide Prevention.
