The Audit Report concludes that financial statements are presented fairly for the year ended June 30, 2020, and that the auditor did not identify any deficiencies in internal control or compliance deficiencies that were considered to be material weaknesses. Additionally, the Audit Report found the County Office of Education complied, in all material respects, with the types of compliance requirements applicable to the state programs subject to testing. The Audit identified that the County Office was not in compliance with Education Code requirements related to annual instructional minutes. The annual Audit Report is attached for review.
