9. BUSINESS/ACTION ITEMS

9.1 Charter Schools Update (MCCHESNEY) - INFORMATION

Neil McChesney, Coordinator of Charter School Oversight, presented an update on the County Board authorized charter schools. Topics included updates on CCCBOE charter site visits, notices of concern updates, legislative updates and charter data book.

9.2 Presentation on CORE/ROAR (Center for Recovery and Empowerment) (BERGER) – INFORMATION

Nick Berger, Senior Director, Student Programs, introduced Lara Zanzucchi, LCSW, Program Supervisor, CORE/ROAR (Center for Recovery and Empowerment) and Gerold Loenicker, Mental Health Program Chief at Contra Costa Health, to present an overview of the Center for Recovery and Empowerment, an outpatient specialty youth mental health and substance abuse treatment program. Golden Gate Community School and Contra Costa Health have partnered together to support students with this program. The program is a pilot project funded by the Mental Health Services Act (MHSA) Innovative Grant and serves youth ages 13-18 who receive MediCAL benefits or who are uninsured. ROAR is a multi-disciplinary team consisting of a Program Manager, Program Supervisor, Therapist, Substance Use Counselor, Peer Specialist and Accredited Teacher. There are three main components of the program: Education, Mental Health and Substance Use.

9.3 Overview of Preliminary Administrative Credential Program (PASC) (TOKUYOSHI) – INFORMATION

In February 2022, the agency launched an administrative credential program. The Administrative Leadership Program (ALP) provides three types of support for educational leaders in Contra Costa County. Marsha Tokuyoshi, Assistant Superintendent, Educational Services, introduced Julie Dooley, Administrative Leadership Program Coordinator and Coordinator of Education Services, who presented an update about the Preliminary Administrative Credential Program (PASC).

9.4 Transportation Service Plan (CLARK) – ACTION

Home-to-School (HTS) Transportation Reimbursement was implemented by Assembly Bill (AB) 181 (Chapter 52, Statutes of 2022) and amended by AB 185 (Chapter 571, Statutes of 2022). It provides reimbursement funding for our school districts and county offices of education based on the prior year eligible transportation expenditures and prior year Local Control Funding Formula transportation related add-on funding. In accordance with the requirements of HTS, a Transportation Service Plan was adopted by the County Superintendent of Schools on April 1, 2023.
