### **5.3 Student Recognitions – INFORMATION**

One of many roles of the County Office of Education is producing and sponsoring academic events. This spring, the Communications Office worked to provide students with the opportunity to participate in several academic competitions. The agenda items recognizes students who went on to represent the county in state and/or national poetry and spelling competitions.

Poetry Outloud: This is the first year the county has hosted the Poetry Outloud contest. The Board recognized Harper Iles, a sophomore at Pinole Valley High School in Pinole, is Contra Costa County's 2023 Poetry Outloud winner. With expressive recitations of the poems by Emily Dickinson and Stephen Dunn, Iles became the county champion during the annual poetry event held on February 11, 2023, at Las Lomas High School. Iles represented Contra Costa County at the California Poetry Outloud State finals.

Spelling Bee: For the first time since 2019, the San Francisco Bay Area held a regional spelling bee. The Rotary Club of San Ramon Valley sponsored and hosted the regional event for the 11 Bay Area counties. The top students from Contra Costa County were then given the opportunity to represent the county at the California State Spelling Bees.

Dhruv Subramanian, a seventh grader at Windmere Ranch Middle School in San Ramon Valley Unified School District, is one of three students from the Bay Area who will compete in the Scripps National Spelling Bee the week of Memorial Day in National Harbor, MD. In addition to competing at the National Bee, he also was the Contra Costa County representative to the California State Junior High School Spelling Bee on Saturday, May 13.

Benjamin Bress, a fifth grader at Del Rey Elementary School in the Orinda Union School District, placed in the top 10 at the regional contest and represented Contra Costa County in the California State Spelling Bee held in Stockton on Saturday, May 13.

## 9.2 UPK Mixed Delivery Grant Presentation (TOKUYOSHI) - INFORMATION

#### 9.4 Labor Agreement Proposals (GONZALES) – INFORMATION

Norma Gonzales, Assistant Superintendent, presented the initial proposal from CCCSEA/CTA/NEA for Reopener Agreement and initial Management Proposal for Reopener Agreement with representatives of the Certificated Unit. These proposals were presented in accordance with Administrative Regulation (AR) 4143.1 regarding the public noticing of collective bargaining proposals. AR 4143.1 provides that initial collective bargaining proposals shall be presented to the Board of Education and County Superintendent of Schools in public during a regularly-scheduled Board Meeting. Following initial presentation of this proposal, the Board schedules a public hearing at the next regularly scheduled meeting in order to receive public input.

### 9.5 Policy Standing Committee: First Reading and Review (MACKEY) – INFORMATION

Superintendent Lynn Mackey presented to the Board proposed changes and eliminations of Board policies as discussed and brought forward by the Policy Committee for first reading. The policies that were presented include updates that reflect newly proposed procedures and guidelines outlined by CSBA or are new to CCCOE. In addition, an update was presented to BB 9150 Student Board Members which was approved at the February 22, 2023, Board meeting. The policies will be presented again at the May 31, 2023, Board meeting for second reading and approval.

### 9.6 Student Board Member Selection Process (MACKET) – ACTION/DISCUSSION

Superintendent Mackey introduced the procedures and implementation for selectin a Student Board member. The criteria, eligibility requirements, timeline, process and rubric were discussed by the Policy Committee at the May 8, 2023, committee meeting and approved to be presented to the full Board. The Student Board member position was approved by the full Board during the February 22, 2023, Board meeting (BB 9150). BB 9150 was presented for first reading at this evening's Board meeting to update the length of term from six months to one year.
