9.4 Presentation on the Local Indicators for Contra Costa County Office of Education (BERGER) - INFORMATION

The Local Control Funding Formula (LCFF) that passed in 2013 created an accountability system that is based on multiple measures. These measures are used to determine local educational agency (LEA) and school progress toward meeting the needs of their students.

9.6 Investment Activities (PORTERFIELD) - INFORMATION

Denise Porterfield, Deputy Superintendent, Business Services, presented the Investment Report as of March 31, 2022. CCCOE has a total of \$47.9 million as investments in the pool, of which \$46.5 million was held at the County Service Fund at the treasurer. CCCOE earned \$107,494 in the third quarter demonstrating we have a strong cash balance in our treasury and can meet our payroll obligations and bills.

9.7 UPK Planning and Implementing Grant (TOKUYOSHI) - INFORMATION

The 2021-22 State Budget package established the Universal Prekindergartern (UPK) Planning and Implementation Grant Program as a state early learning initiative with the goal of expanding access to prekindergarten programs at local educational agencies (LEAs). California is embarking on systematic change for universal access to quality early education with the goal of having children that are better prepared in school, in terms of early literacy, language, math, executive function and social emotional development skills.

9.8 Charter School Update (MCCHESNEY) – INFORMATION

Neil McChesney, Charter Oversight Coordinator, informed Board that Invictus co-Executive Director Shawn Benjamin will continue in the primary leadership role while Gautam Thapar steps down for the upcoming school year. Caliber: Beta Academy is moving to a newly constructed and renovated facility in the Hilltop neighborhood in Richmond. It will be the first time the school will be in its own facility. Clayton Valley Charter High School is rebranding its independent study program as "Eagle-I" and is actively recruiting students/families. CVCHS informed CCCOE it has purchased a facility at 1300 Alberta Way, across the street from its current campus. It plans to use the facility for overflow office space and will not be used for any student programming or instruction.
