## 5. PUBLIC HEARINGS

## Public Hearing on the Petition to Establish the Contra Costa School of Performing Arts (CCSPA)

President Mirabella read a statement explaining the public hearing procedure. The public hearing was opened at 5:43 p.m. Associate Superintendent, Business Services, Bill Clark introduced Neil McChesney, lead petitioner for CCSPA. Mr. McChesney gave a PowerPoint presentation which included information about changes to the program since it was last presented. He said he believes the current petition is stronger than the last and that the community has a strong demand for performing arts outside what the Mt. Diablo Unified School District provides. He highlighted that the audition process has been removed and said they have worked hard to clearly define what an integrated curriculum is and how it will work.

In answer to a question from Mr. Gomes, Mr. McChesney explained that the Charthouse Public Schools Corporation, which he founded, is a nonprofit benefit corporation with the express mission of supporting and establishing charter schools where there are areas of need. Mr. Gomes pointed out that the bylaws state the corporation can function outside of California and asked Mr. McChesney to clarify. Mr. McChesney said he will consult with legal to see why it is in the bylaws and that he is willing to modify the corporation bylaws, unless there is a specific reason that legal counsel says they cannot be changed.

Mr. Belle asked for an explanation of the outreach plan. Mr. McChesney said the appendix of the petition identifies specific organizations, locations, times and means of communication that will be undertaken in order to make sure all the various demographics in MDUSD are represented.

President Mirabella inquired about letters of commitment beyond the \$20,000 that is in the petition. Mr. McChesney replied that they now have approximately \$30,000. He said they have a comprehensive budget that is fiscally solvent and sustains the program. In response to concerns expressed by Ms. Mirabella regarding special education funding, Mr. McChesney explained that projections have been based on the MDUSD special education population. Also, the outreach program that's been developed includes special education.

Mr. McChesney offered to arrange a site visit for Board members to show them the Concord Pavilion and help them visualize how the school will look. If the Concord Pavilion is not used, they will use unutilized MDUSD facilities via Proposition 39.
