10.1 Charter Schools Update (MCCHESNEY) – INFORMATION

Neil McChesney, Charter Schools Oversight Coordinator, presented an update on the County Board authorized charter schools. Topics covered were an update on Board member charter school visits and an overview of LCAP presentations. McChesney also introduced representative from Caliber: Beta Academy and Invictus Academy of Richmond for their annual LCAP presentations. These presentations are an opportunity for the charter schools to inform the Board members of their current performance and progress with focus on their most recent LCAPS and their goals, actions and expenditures associated with it.

Principals Andrew Grossman and Aleesha Spurr presented the 2023-24 LCAP for Caliber: Beta Academy. Executive Director Shawn Benjamin, and high school Principal Lauren Rahlson presented the 2023-24 LCAP for Invictus Academy of Richmond.

10.2 Update on the County School Service Fund (CSSF) Investment Activities (PARASIDIS) - INFORMATION

Daniela Parasidis, Deputy Superintendent, presented the CSSF Investment Activities for the quarter ending June 30, 2023 and showed that the CCCOE certified the investments and are in compliance with the investment policy and has the ability to meet its budgeted expenditures and is in compliance with government code 16481.

10.3 Passive Park Update (MACKEY) – DISCUSSION/UPDATE

Superintendent Mackey updated the Board on the changes to the passive park that is being constructed on Santa Barbara Road adjacent to the CCCOE's Stewart Building. At the August 12, 2020, meeting, the Board approved quit claiming the easement next to 77 Santa Barbara Road to Contra Costa County. Board members also received an update on the status of trees that were supposed to remain but were removed due to health concerns.
