Associate Superintendent, Business Services, Bill Clark, explained Board policy requires an annual item on the agenda regarding Superintendent's compensation. He shared new changes in State Teachers Retirement System (STRS) law no longer allows a separate payment for mileage stipends.

Gomes moved, Belle seconded, and the Board voted 5-0-0 to approve adjusting the compensation of the County Superintendent in accordance with the recently approved agency settlement of four (4) percent, effective July 1,

2014, for the 2014-15 fiscal year and to restructure the salary of the County Superintendent by eliminating the current annual mileage reimbursement of \$7,200 and adding this amount to the annual compensation of the County Superintendent.
