9. SUPERINTENDENT'S UPDATE

9.1 Two County Office Experiences with Workforce Housing (MACKEY) – INFORMATION

Superintendent Lynn Mackey introduced Steve Herrington, current Sonoma County Board of Education member and former Sonoma County Superintendent, and San Mateo County Office of Education Deputy Superintendent Kevin Bultema who shared with the Board their experiences with workforce housing from two different county offices of education perspectives.

9.2 Multilingual Learner Support (TOKUYOSHI) – INFORMATION

Assistant Superintendent, Educational Services, Marsha Tokuyoshi introduced Lilia Tsui, Coordinator and English Learner Specialist, who gave an update on Multilingual Learner Support. The presentation included a review of California's English Learner Roadmap and the state's vision for all English Learners, the progress of English Learners in Contra Costa County, and also identified how CCCOE supports districts at the regional and county level.

9.3 2022/2023 Student Data Summary for Mt. McKinley (BERGER) – INFORMATION

Nick Berger, Senior Director, Student Programs, presented the annual student data report for Mt. McKinley School. The report includes a three-year comparison of student demographics, academics, enrollment and discipline data. Berger also shared how this data is used, including in the SARC, SPSA, LCAP and others.

9.3 Presentation on Tobacco Use Prevention Education (TUPE) Program (BERGER) – INFORMATION

Nick Berger, Director, Student Programs, introduced Emily Justice, Manager of the TUPE program who presented an overview of the services provided to school districts in the county through the Tobacco Use Prevention Education program. The goal of the tobacco use prevention education is to prevent or reduce the use of tobacco and nicotine addiction among the student population through tobacco-specific, evidence-informed educational instruction and activities. The program is funded through the California Department of Education – Prop 99 and Prop 56.

9.5 Update on Arborist Report (MACKEY) – INFORMATION

Superintendent Mackey gave an update on the Pleasant Oak passive park project located next to the Stewart Building on Santa Barbara Road. She presented the arborist report from 2021 indicating the health of trees. This was a follow up discussion from the September 13, 2023, Board meeting.

9.6 Superintendent's Update

- The quarterly usage report of the electric car charging stations will be pulled after the first quarter but everything is running smoothly and the stations are being used.

- California governor signed a law that said county offices will be distributing Narcan to support districts. All of our schools already have Narcan on campus and staff is trained, and the districts in the county have also been trained in the use of Narcan.
- The governor signed a bill that allows giving a stipend to Student Board members. The policy committee will need to revisit the policy to update and present to the Board for approval.
- Teacher of the Year was a great event and it is a busy and productive time for our staff

Daniela Parasidis, Deputy Superintendent, Business Services, gave the Board an update on the 2022-23 Unaudited actuals Financial Report for the Contra Costa County Office of Education. The budget cycle is ongoing beginning with the Board approval of the budget in June, then it is reviewed periodically throughout the year based on new assumptions.

Daphne Millich -

- Met with San Ramon Valley Unified Student Senate, composed of student representatives from middle and high schools from around the district
- The following topics are from peers that have asked her to mention as a means to create better understanding of how students are feeling and what they want to work towards changing:
 - Inclusivity/Awareness: Drug Awareness committee was happy to hear about the new Narcan laws that was recently passed.; The Monte Vista High School Student Diversity and Equity Leadership Council is making presentations against racism and homophobia and given to athletic directors and coaches to prevent team bullying; students discussed statements of recognition or neutrality pertaining to recent conflicts; more diverse hiring in faculty
 - School Environment/Safety: Students feel awareness and representation of the LGBTQIA community is good at the high school level; it was noted that there is bullying at the middle school level towards the LGBTQIA community and not all students are feeling safe; noted academic stress among students related to the lack of consistency in grading among teachers who teach the same classes.
 - Accessibility/Resources: Music/art programs tend to be based on wealth/income but all students should have access; More stress management for teachers; San Ramon Valley and Cal High are starting a teaching program where students have the opportunity to be teaching assistants at middle and high schools.
