The Petition requests the transfer of a small portion of a larger development that is primarily located in AUSD boundaries. The reason for the transfer is simple. Current boundaries would result in splitting approximately 17 parcels of real property in the Hill Park Ridge Development located in the city of Antioch (the "Project").

WHEREAS, Education Code 35704 provides that, within 30 days after any petition for reorganization is filed, the County Superintendent of Schools shall examine the petition, and, if it is found to be sufficient as required by law, shall transmit the petition simultaneously to the Contra Costa County Committee on School District Organization and the California State Board of Education to execute the transfer of territory between school districts.
